

Limited One-Year, 10-Year and 15-Year Warranties

Subject to proper installation and normal use, Rainbow Play Systems, Inc.® warrants, subject to the limitations stated below, to the original retail purchaser for residential use only, all chain, seats, swing-hangers, all Redwood components, hardware, metal braces, canvas, Slides, and accessories to be free of defects in material and workmanship for a period of ONE YEAR from the date of purchase. **Seasonal checks and surface cracks are not considered defects in material and workmanship as they are a natural characteristic of all wood.** Merchandise covered under this limited one-year warranty will be repaired or replaced, at our option, and returned to the customer, freight prepaid. Any service work that must be performed on site that does not qualify under the warranty specifications will be billed directly to the purchaser.

In addition, for a period of 15 YEARS from the date of purchase, Rainbow Play Systems, Inc.® warrants, to the original retail purchaser for residential use only, all heartwood Redwood components against structural failure due to corrosion, wood rot or insect infestation. In addition, for a period of 10 YEARS from the date of purchase, Rainbow Play Systems, Inc.® warrants, to the original retail purchaser for residential use only, all common Redwood components against structural failure due to corrosion, wood rot or insect infestation. **We strongly recommend the application of water sealant. Seasonal checks and surface cracks, a natural characteristic of all wooden play equipment, not resulting in structural failure, are not covered under this warranty.** This limited 10-year warranty also applies to bronze bushing swing hangers and scoop slide® bedway. Components covered under this limited 10-year warranty will be replaced, free of charge, and returned to the customer, freight collect. If you are dealing directly with your local factory showroom, all labor costs, travel expenses and any other charges involved in the installation or replacement of the parts will be your (the purchasers) responsibility.

Rainbow Play Systems, Inc.® reserves the right to examine photographs or physical evidence of merchandise claimed to be defective, and to recover said merchandise, prior to disposition of warranty claims. Merchandise returned to our factory for examination or recovery must be shipped freight prepaid, unless a Return Authorization Number is issued.

No warranty is offered on residential equipment subjected to commercial use, abuse, negligence, improper installation, vandalism, acts of God, unauthorized alteration or attachment to equipment other than our own.
