Complete trampoline frame including all frame-poles & rods.



Trampoline mat/net (excluding print fading) & net poles.



All Free Jump accessories, e.g. basketball hoop & ladder.



## Free Jump® Trampoline Warranty

What is covered and how long does it last: Subject to proper installation and normal use, Free Jump warrants, subject to the limitations and requirements stated below, to the original retail purchaser for residential use only, that certain components described below purchased from Free Jump or authorized dealers (the "Products") will be free of material defects in material and workmanship for the period set forth below from the date of purchase, as follows:

**10 Year Warranty:** Trampoline frame including all frame-poles and rods. **3 Year Warranty:** Trampoline mat/net (excluding print fading) and net poles.

**12 Month Warranty:** All Free Jump accessories, e.g. basketball hoops and ladders.

THE FREE JUMP TRAMPOLINE LIMITED WARRANTY COVERAGE DESCRIBED HEREIN LASTS ONLY AS LONG AS THE ORIGINAL RETAIL PURCHASER OWNS THE PRODUCT AND TERMINATES IF THE ORIGINAL RETAIL PURCHASER SELLS OR OTHERWISE TRANSFERS THE PRODUCT. Free Jump recommends that the original retail purchaser affix the original sales receipt to the Product manual and retain these documents. Your Free Jump Exclusive Limited Warranty is non-transferable.

What is not covered: The Free Jump Limited Warranty does not cover: (1) cosmetic damage or defects, such as paint, rusted parts, surface scratches, dents, marring, fading, discoloration, or cracks that do not affect the functionality of the Product; (2) damage due to normal wear and tear; (3) damage due to "acts of God", including , but not limited to, hail, flooding, lightning, tornadoes, sandstorms, earthquakes, and windstorms; and (4) damage due to "environmental factors", such as wind-blown sand, salt water spray, and airborne emissions from industrial sources (sulfur, acids, or corrosive chemicals, other than photochemical smog). Due to the metal's properties, when the aluminum rods are overloaded by user, some of the rods may be slightly deformed. Rods, if slightly deformed, are not covered under our warranty. They do not affect the functionality of the trampoline.

## **Termination of Warranty:** IF ANY OF THE REQUIREMENTS BELOW ARE NOT FOLLOWED, THIS WARRANTY IS NULL AND VOID: The Product:

- Must be erected in conformity with the installation instructions furnished by Free Jump using approved parts;
- Must be maintained and inspected in accordance with instructions from Free Jump;
- Must be subjected only to normal residential use and normal trampoline related activities;
- Must not have been subjected to vandalism, misuse, neglect, or accident; and
- Must not have been subjected to unauthorized addition or substitution of parts not approved by Free Jump in writing.

Necessary maintenance or repairs on Free Jump Products can be performed by persons other than Free Jump; however, any modifications or damage caused to your Free Jump Product by you or any persons other than Free Jump, in the sole judgment of Free Jump, affects the condition or operation of the Product, may void the Free Jump Limited Warranty. How to get service: Please contact your local distributor by calling 1-800-RAINBOW or via register.rainbowplay.com for any warranty service.

Free Jump reserves the right to examine photographs or physical evidence of the Product, or component parts thereof, claimed to be in disposition of the warranty claim. If applicable, Products returned to the Free Jump factory for extermination or recovery must be shipped freight prepaid, unless Free Jump issues a Return Authorization number. Do not discard any parts until your warranty has been approved.

**Remedy:** Your sales receipt will be needed to make a warranty claim. Free Jump may ask you for photos for your warranty claim. Shipping and labor costs are not covered under this warranty. Warranty claims will be repaired or replaced as determined by Free Jump.

This warranty provides you with legal rights, which vary from state to state.
